How do I take part?

2. **For the Top 20 Partners[^]**, who achieve the highest number of points during this timeframe, will be invited to an exclusive afternoon in London in February 2026, with your Regional Directors, Ernesto Hartog, Simon Bowler, and other special guests!

[^]Top 20 Partners will be split by region:

- Top 5 for Partners from Central Europe
- Top 2 for Partners from Western Europe
- Top 7 for Partners from Southern Europe
- Top 4 for Partners from Northern Europe
- Top 2 for Partners from Eastern Europe

Note: Israel will not be participating in this incentive

Leader boards will be shared bi-weekly for you to track your position to be in the chance of winning a trip to London, as well as local event calendars to encourage your team to join any events local to them!

Event Guidelines

For the purpose of this 90/90 Summer/Autumn Campaign please see the below guidelines to take part in this:

- *An event can include: team training, business opportunity meeting, product training etc. This can be held within an event space, local spaces such as coffee shops, hotel receptions or at a home address
- You must complete this [online form](#) ahead of holding the event.
- You must share the flyer as proof the event when registering the event as Point 2
- A minimum of 10 people must be present for the event, excluding yourself and event needs to be open to everybody
- A maximum of 2 hosts can be added to the event calendar – for events more than 150 people, we will allow 3 hosts but this must be shared with your BD beforehand

Terms & Conditions:

- The overall incentive will commence on 1 January 2025 00:00 BST and will close on **31 December** 2025 23:59 BST
